## What is Cross Enrollment?

Mt. San Jacinto College (MSJC) participates in a cross-enrollment program with the California State University (CSU) and University of California (UC) campuses. Mt. San Jacinto College students may enroll in one course per term (limited to two courses per year) at any CSU or UC on a space available basis without formal admission and without payment of university tuition fees.

## **How can I qualify for Cross Enrollment?**

You are eligible for Cross Enrollment if you have met all of the following requirements at MSJC:

- ✓ Have earned California resident status.
- ✓ Completed at least one regular semester at MSJC.
- ✓ Earned a grade point average of 2.0 for college work completed.
- ✓ Enrolled at MSJC for a minimum of six units for the current term
- ✓ (Fall or Spring).
- ✓ Paid appropriate enrollment fees at MSJC.
- Completed appropriate academic preparation for the course you intend to take as determined by the host campus. The host campus is where you will take the additional class.

## **Cross Enrollment Conditions**

Approval for Cross Enrollment is valid for only the term specified and is subject to space availability, deadlines, registration procedures and priorities of the host campus. You must reapply for each term you wish to cross enroll.

You will not be charged fees at the host campus; however there is <u>minimum</u> \$40 administrative fee per unit for each term payable to the host campus. In addition, you will have to pay any fees required of other students, such as lab, parking, materials, computer use, etc.

Records of credit earned through Cross Enrollment are maintained at the host campus. You may request that a transcript be sent to MSJC to ensure

course credit for general education certification, Associate's degree requirements, etc.

The program is limited to baccalaureate courses, pre-collegiate or extension courses are excluded.

Financial aid is available only through MSJC. Units taken at MSJC and the host campus may be combined to establish financial aid. Consult Financial Aid Office for further information.

Participation in the host campus' student activities is subject to any limits set by the host campus. Health services at the host campus are limited to emergencies.

You are responsible for host campus parking fees and regulations.

If you drop the host campus class, you must follow the drop procedures for that campus.

## Mt. San Jacinto College Procedures

- Cross Enrollment forms available at the Counseling and Career/Transfer Center offices.
- Although not mandatory, students are urged to meet with an MSJC Counselor.
- The Cross Enrollment application must be signed-off and stamped by MSJC Enrollment Services before it can be taken to the host campus for enrollment.
- Applications will not be processed more than three weeks in advance of the beginning of the semester/quarter at the host campus. More information will be given to students regarding other procedures at the host campus.
- ✓ Allow at least 48 hours for MSJC Enrollment Services sign-off on the application.

**WARNING:** Participation in Cross Enrollment may affect your community college transfer eligibility. This applies to students with credit from previously attended baccalaureate institutions. At least 30 of the last 40 units and last two terms must be at a California Community College immediately prior to transfer.
