- 4. Apply for Financial Aid FAFSA® Application [MSJC Federal School Code: 001246] (optional)
- 5. Obtain Your Username & Student ID Number Self-Service ea.msjc.edu
 - a. On the Log In Page, click on "What is my Username and Student ID?". You should have received an email with this information as well.
- 6. Orientation https://login.msjc.edu/ (may take up to 24 hours for your completion to show)
- 7. **Placement** Students who graduated from high school within the last 10 years are eligible for Math and English placements based on high school transcript information reported on their admissions application. Click here to learn more: www.msjc.edu/MultipleMeasures. For those who have not received a placement based on multiple measures, our counselors can help with a placement clearance form.
- 8. Activate Student Email Enrollment Services emails Registration Dates and Times. Check your MSJC email.
- 9. **Submit Transcripts** Official transcripts can be sent electronically from an institution or vendor via email to officialtranscripts@msjc.edu. Paper transcripts may also be mailed if they remain unopened.
 - a. Submit all previous transcripts from any schools attended including military transcripts for evaluation.
 - b. If using Federal VA benefits all official transcripts must be received by the end of the second semester.
