







## Kaiser Permanente Members: Participate in REEP Wellness activities and earn \$125 in rewards!

As part of the REEP Wellness program, school district employees enrolled in a Kaiser Permanente medical plan through REEP can earn a \$125 gift card by completing various wellness activities between July 1, 2018 and May 31, 2019.

#### Here's how to do it:

## Step 1: Sign on and register.

√ Visit <a href="http://kp.org/engage">http://kp.org/engage</a> and register. If you have already registered, you will just need to enter your kp.org user ID and password and agree to the Wellness Program Agreement on the rewards platform.

## Step 2: Participate

- ✓ Complete all wellness activities which are listed on the "My rewards" page. Wellness activities. each participant is required to complete are as follows:
  - Total Health Assessment



Biometric and Cancer Screening Compliance (Age/Gender Appropriate) - Kaiser Permanente Members can utilize past screening results. Log in to the Kaiser Permanente Rewards platform for a list of required screenings. Completed screenings are indicated with a green check mark. After logging into the rewards platform there may be a 3week delay before the green check mark appears for completed Biometric and Cancer Screenings. Any outstanding screenings will need to be completed with your Kaiser Permanente physician to receive credit. Please review FAQs on the rewards platform for further information.

# Step-By-Step Instructions

You'll need to accept the Wellness Program Agreement to participate. Here's how:

## 1. Sign on

- Go to <a href="http://kp.org/engage">http://kp.org/engage</a> and click on the "Sign-on" button.
- Sign on by entering your kp.org user ID and password.
- If you are not registered at kp.org, click the "Register now" button to get a user ID and password.

## 2. Agree

- To receive credit for your activities, check "Yes" to accept the Wellness Program Agreement, then click "Submit."
- If you check "No," you will not earn credit for your REEP wellness program activities.


