DMS Program Mission Statement

The Mission of the Diagnostic Medical Sonography Program at Mt. San Jacinto College is "to prepare competent entry-level general sonographers in the cognitive (knowledge), psychomotor (skills), and affective (behavior) learning domains".

The DMS program will continually strive to provide students with high quality education and excellent clinical training, under qualified supervision, to prepare the student for future employment as a Diagnostic Medical Sonographer.

7he DMS program is dedicated to student preparation for the American Registry of Diagnostic Medical Sonographer exams to become a registered sonographer.



General Information

Following completion of the pre-requisite courses the Diagnostic Medical Sonography Program curriculum covers four regular semesters and requires an eight-week summer session between the first and second years of study. The DMS Program prepares the student to work in an ultrasound department performing abdomen, superficial structural, gynecology, and obstetric ultrasound exams.

Accreditation Status - Accredited

The Diagnostic Medical Sonography Program is accredited by the Commission on Accreditation of Allied Health Education Programs – 9355 113th St N #7709, Seminole, Florida 33775 - Joint Review Commission for Diagnostic Medical Sonography. This achievement places MSJC's DMS program among the top programs in the United States.

Accreditation increases opportunities for student clinical training, strengthens the student learning process, and opens doors to student employment. Students enrolled in accredited DMS programs are eligible to take the American Registry of Diagnostic Medical Sonography (ARDMS) board exams up to 60 days prior to graduation, improving employment rates of program graduates. Student demand for MSJC's DMS program is also expected to increase as a direct result of the program's accreditation.

Essential Functions

Physical Demands:

- Possess the ability for extremely heavy effort (lift/carry 50 lbs. or more).
- Perform prolonged, extensive, or considerable standing/walking, lifting, positioning, pushing, and/or transferring patients.

- Possess the ability to perform fine motor movements with hands and fingers.

English Language Skills:

Although proficiency in English is not a criteria for admission into the DMS Program, students must be able to speak, receive, write, and read English to satisfactorily complete classes and to ensure safety of themselves and others.

Learning Disabilities:

If any student has been diagnosed and documented with a disability, faculty must be notified. The department is willing to meet any reasonable request for accommodation. However, the responsibility remains with the student to provide relevant and recent written documentation from the DSPS, that such a disability exists, as well as all recommendations by the DSPS for helping the student.

Approximate Expenses

When planning expenses students should be aware, they may have to limit their hours of employment due to extensive DMS Program requirements. Scholarships, grants and loans are available to those students who qualify through the MSJC Financial Aid office

- 1. Students pay for tuition, ASB card and a parking permit as stated in the current college catalog.
- 2. Tuition \$46.00 unit (57 units)
- 3. Designated by the Nursing-Allied Health Department \$70.00
- 4. DMS textbooks and supplies \$400-\$600
- 5. SDMS membership and journal access \$40 or AIUM student membership \$25
- 6. CPR course -\$65 (Must be American Heart Association/Healthcare Provider -BLS)
- 7. Physical Examination/laboratory tests \$300-\$500
- 8. Background Clearance + Drug Screening + Medical Document Manager \$122
- 9. Transportation cost to and from training site- Variable
- 10. Liability Insurance covering students is provided by the college at no cost to the student.
- 11. Students who are assigned to Desert Regional Medical Center for Clinicals will have to provide a Drug screening within 30 days of placement.
- 12. Conferences: Edelman Physics conference (\$300), UCLA Fetal Echo Conference (\$125) and San Diego Perinatal Conference (\$25).
- 13. After course completion: ARDMS SPI (Sonography Physics and Instrumentation) and specialty exams \$250 each.

Students are required to carry their own Professional Liability Insurance, \$1-3 million. Approx. \$25. Students are also required to show proof of Personal Health Insurance, which is required by Clinical Sites.

Proof of these two items must be uploaded onto Castlbranch.com Any student who does not submit this information will not be able to attend clinicals.

Limitations

NOTE: If you have been subject to revocation, suspension, or disciplinary action by: a) state licensing board; b) federal agency; c) national professional association, and/or are presently charged with, or have ever been convicted or found guilty of, or pleaded nolo contendere to any crime or misdemeanor directly related to public health and safety, and/or the provisions of diagnostic medical sonography or vascular technology services, you will be required to declare this on your national registry application to take the examination. These activities may affect your eligibility to take the national registry examination. You may apply to the ARDMS to determine your eligibility status. All students assigned to a hospital will be required to complete a background check for any felony or misdemeanor.

Admission Requirements

Note: Meeting admission criteria for the program does not guarantee admission into the program.

The following must be met prior to the application deadlines.

- 1. Admission to Mt. San Jacinto College, complete online orientation
- 2. Proof of High School Diploma, GED, California Proficiency Exam or College Degree
- 3. Submit Official Transcripts to <u>officialtranscripts@msjc.edu</u>, from all Colleges and/or Universities attended to Enrollment Services. Transcripts must be sent directly from Colleges or Transcript Vendors. Transcripts forwarded by students will be considered unofficial.
- 4. Attend Information Workshop or View Presentation on Website. (Must attach proof to application)
- All students are required to meet with a college counselor prior to applying to the Diagnostic Medical Sonography Program (DMS) to complete a <u>Nursing and Allied Health Evaluation Request</u> July 1-December 1.
- 6. A minimum cumulative GPA of at least 2.5 on a 4.0 college scale and a grade of "C" or better in the following admission requirement courses (prerequisites):

- 7. Once all prerequisites are in progress or have been completed, students are required to meet with a counselor to submit a <u>Nursing and Allied Health Evaluation Request</u>. This request must be completed July 1 December 1 to be eligible to apply for the program beginning the following Fall semester. **Please Note:** Evaluations are only valid for 9 months.
- 8. If evaluation results confirm eligibility, download an application from the MSJC Nursing and Allied Health website and submit it during the application filing period, March 1 15.
- 9. Students must pass the TEAS VI Test with a 70% or higher. MSJC will not proctor the TEAS test on campus. Please register for the TEAS VI test on the <u>ATI Website</u>. Student are allowed 2 attempts per application period.

Transcript Requirements

Official transcripts from all colleges and/or universities attended must be submitted electronically to Enrollment Services at officialtranscripts@msjc.edu. Students completing all coursework at Mt. San Jacinto College only need to submit the Nursing and Allied Health Evaluation Request. A written report of your transcript evaluation and application eligibility will be sent to your MSJC student email only. Once the evaluation is completed, the student will receive an eligibly email with a link to "program notes" through their MSJC student email only.

Note: Deadline to submit a Nursing and Allied Health Evaluation Request Form is **July 1**st - **December 1**st for the March 1- March 15 Application Filing period.

All **FOREIGN TRANSCRIPTS** including high school documentation must be formally evaluated by The National Association of Credential Evaluation Service= www.naces.org **See a Counselor for details/application**.

Application Filing Period

Admission will be offered to the highest-ranking applicants whose documentation supports the information provided in the application.
